## 4. **Furnishings.**

Norkett will make every reasonable effort to provide appliances and amenities in good working order and repair them during the tenancy upon notice from Guest but Guest understands that Norkett can make no guarantees that any such appliances or amenities will be working during the entire tenancy, and that the Guest will not be entitled to any refund if they are not.

### 5. Some Simple Rules.

- a. No pets are allowed in any rental units.

#### 6. <u>Cancellation by Tenant.</u>

Guest agrees that Norkett himself or his respective representatives may enter the Premises to inspect the Premises, to make such repairs, improvements, or alterations thereto as Norkett may deem necessary. Guest shall not assign this Agreement or sublet the Premises in whole or part without written permission of the Norkett.
